Tire Chalking

Police Chief Hurley provided information about a newsletter that came out noting a recent court action that pursued requiring a warrant to chalking tires to monitor parking time. The continuing discussions will be monitored.

Historic Loss of Parking Spaces at Ocean Beaches

Wayne Clough noted he recently found a way to provide a more accurate count of the loss of spaces since the early 1980's using Google Earth Pro. Based on his preliminary review it appears that the estimates of 250 spaces lost that have been previously noted may be high. He will continue the review and report back at the next meeting.
